#### Minutes of the previous meeting

1. The minutes of the 6 July 2017 meeting were agreed with minor amendments.

#### Matters arising

2. The Secretary advised that the Boundary Commission for England had submitted an entry for the Civil Service Award "Digital" Category on behalf of the UK Commissions.

#### **Business Update**

- 3. The Commission noted that Afzal Khan MP had secured a slot for a Private Members' Bill relating to the 2018 Review; 2<sup>nd</sup> Reading is expected in December 2017; an update will be given at a future meeting.
- 4. Shonaig Macpherson, Non-Executive member of the Joint Management Board at the Scotland Office, had requested an introductory meeting with the Deputy Chair. The Secretary would confirm the arrangements in due course.

## Consideration of Revised Proposals - Clackmannanshire, Falkirk, Fife, Perth & Kinross and Stirling council areas (Paper 2017/78)

- 5. At its meeting of 6 July 2017, the Commission had considered revised proposals for Clackmannanshire, Falkirk, Fife, Perth & Kinross and Stirling council areas (see Paper BCS 2017/72).
- 6. At that meeting, the Commission agreed to retain the proposed constituency boundary at Buckhaven but deferred its decision on the boundary west of

Kirkcaldy and asked the Secretariat to further develop an option that retained Clackmannanshire council area within a single constituency.

- 7. The Commission considered that both Option 1 and 2 retained 3 constituencies from the Initial Proposals thus minimising change; and both options addressed issues raised during the consultations, mainly opposition to the proposed Kinross-shire and Cowdenbeath constituency.
- 8. The Commission noted that Option 2 retained historic ties within Clackmannanshire council area and minimised the division of Stirling between constituencies. It noted that Falkirk was already split in the Initial Proposals.
- 9. The Commission discussed Options 1A and 2A that followed the same boundary to the west and south of Kirkcaldy to retain Kirkcaldy within a single constituency. The Commission preferred Option 2A as it also improved the constituency boundary in Dunfermline by following ward boundaries.
- 10. The Commission considered constituency names and agreed to rename the proposed Clackmannanshire and Dunfermline North constituency as "Clackmannanshire and Dunfermline" and Dunfermline and Mid Fife as "Mid-Fife."
- 11. The Commission considered Option 2A an improvement to its Initial Proposals, and agreed to adopt it as its Revised Proposals for its consultation on Revised Proposals for Clackmannanshire, Falkirk, Fife, Perth & Kinross and Stirling council areas.

12. The Commission agreed constituency names and designations for its Revised Proposals based on guidelines in its policy and procedures booklet. These are as follows:
