## 2023 Review of UK Parliament Constituencies Allocation of constituencies

## **Action required**

1. The Commission is invited to note the allocation of constituencies for the 2023 Review of UK Parliament Constituencies and the electorate quota for the Review.

## **Background**

- 2. The Parliamentary Constituencies Act 1986 (as amended), sets out the framework and rules for the 2023 Review which will recommend the boundaries of the Scottish constituencies in the UK Parliament.
- 3. On 5 January 2021, National Records of Scotland and the Office for National Statistics published the electorate data to be used for the 2023 Review, the number of electors eligible to vote at the UK Parliament election at 2 March 2020.
- 4. The total UK electorate for the purposes of the 2023 Review is 47,558,398, including attainers.
  - Scotland 4,079,612
  - England 39,860,421
  - Wales 2,322,677
  - Northern Ireland 1,295,688
- 5. The total electorate for the five protected constituencies is 220,132.
  - Orkney and Shetland 34,824
  - Na h-Eileanan an Iar 21,177
  - Isle of Wight 111,716 (2 constituencies)
  - Ynys Môn (Isle of Anglesey) 52,415
- 6. After applying the formula specified in the 1986 Act the electoral quota for the 2023 Review is 73,392.66 ( $47,338,266 \div 645$ ). This is rounded to 73,393 after calculation of the 5% variance.
- 7. All non-protected constituencies must be within 5% of the electorate quota ie between 69,724 and 77,062 electors. However, if it is considered necessary to do so, the Commission can recommend a constituency with an electorate lower than the minimum if it is larger than 12,000 square kilometres. No constituency can be larger than 13,000 square kilometres. The Commission will wish to consider this area-electorate rule when considering its initial constituency designs.
- 8. The allocation of constituencies to each part of the UK is:
