2018 Review - Project Plan

Action required

1. The Commission is invited to consider the updated project plan for 2017 which appears at Appendix A, and the draft meeting schedule at Appendix B.

Discussion

- 2. The project plan sets out key stages of work to be undertaken in 2017.
- 3. The launch of the secondary consultation has been agreed for 28 February, the same date as the English and Welsh boundary commissions.
- 4. The Secretariat is consulting with the other UK boundary commissions' secretariats on the timing of the consultation on revised proposals: initial feedback suggests that Wales and Ireland are looking at mid-September to October and we are awaiting a response from the English Commission. The advantage of coordinating with the other Commissions is that publicity is likely to be maximised; however, the key factor will be progress with development of revised proposals.
- 5. The meeting schedule proposes monthly meetings and gives a general indication of what might be covered at each. Depending on progress, the Commission may not require all these meetings but it seems prudent to schedule them now. It would be helpful if the Commission could agree a preferred day for meetings. The Secretariat will then canvass dates.
