# Finance Update

#### For Information

- 1. A finance update table is at Appendix A. The Commission is invited to note its financial position as of 23 September 2020.
- 2. The budget shown is as set out in the Corporate Plan 2020-23.
- 3. The overall forecast has fallen by £7,400 compared to that shown in BCS Paper 2020/09 at the Commission's meeting of 20 July 2020. This is chiefly due to savings of c. £6,000 in the Administration budget on office equipment, postage, photocopying and training which reflect that the Secretariat has been working from home and is likely to continue to do so until 2021.
- 4. The Travel and Subsistence forecast also falls by c. £1,000 due to the next UK Commissions meeting now being expected to be held by video conferencing.
- 5. The Secretariat is awaiting clarification on the likely cost of using a shared consultation portal with the other UK Parliamentary Boundaries Commissions at the next Review. At the time of writing, the Secretariat is also awaiting a letter of delegation from the Office of the Secretary of State for Scotland. This is expected to be for c. £400,000.
- 6. The Secretariat was asked by the Office of the Secretary of State for Scotland (OSSS) to submit, in mid-September 2020, a bid for funds for the financial years 2020–21 to 2023–24, as part of Cabinet Office's 2020 Comprehensive Spending Review. The OSSS requested that combined costs from 2021–22 to 2023–24 not exceed £1.2 million.
- 7. The figures submitted by the Secretariat are shown in Appendix B. These are in line with the 2020–23 Corporate Plan, with estimated requirements for 2023–24 reflecting the likely completion of the 2023 Review in June or September 2023, and include costs relating to the printing and proof-reading of the final report, as well as costs related to the consultation portal.
