## For Information

- 1. The latest version of the Risk Register is shown in Appendix A.
- 2. Although the Boundary Commission for Scotland and Boundaries Scotland operate a shared Risk Register, the Boundaries Scotland-specific risks are not shown in this Risk Register.
- 3. The Risk Register has been updated for the 2023 Review, from the version which was discussed at the Commission's meeting on 8 March 2021
- 4. The risk "Impact of re-naming LGBCS to "Boundaries Scotland" has been removed from Risk Register.
- 5. The risk "Ineffective consultation processes" has been split into two risks, to account for (1) lack of engagement with the consultation and (2) misinformation about the Review resulting in consultation responses which misunderstand the rules governing the Review and make suggestions the Commission could not adopt.
- 6. The risk "Unavailability of Computer workplaces/theft or failure of equipment/computer systems" has been updated to add a reference to "Future lockdowns", and revise the reference to limited access to Thistle House.
- 7. The risk "Insufficient staff resource to conduct overlapping reviews" has been updated to remove a reference to the Islands Reviews.
- 8. The risk "Impact of Covid-19 on Public Hearings" has been updated to reflect legal advice received by the Boundary Commission for England.
- 9. The risk "Consultation portal does not meet BCS requirements" has been updated to reflect use of the consultation portal so far during the ongoing public consultation.
- 10. The risk "Use of wards existing or prospective at review date" has been updated to reflect the only council area potentially affected.

	Potential Impact		
High (H)	Risks that can have a major effect on Commission operations. May result in significant financial loss, major disruption to outputs or serious damage to the Commission's reputation.		
Medium (M)	Risks that have a noticeable effect on Commission operations. Each will cause a degree of disruption to outputs and may affect budgets.		
Low (L)	Risks where the consequences and impact will not be severe and any associated losses relatively small. As individual occurrences they will have a negligible effect on Commission operations.		

These are combined to determine the risk category: Red = HH, MH or HM, Amber = MM, HL, LH, Green = LL, ML, LM.
